Dear Customer,

Please be aware that Standard Microsystems Corporation is discontinuing the production of certain devices which you may have purchased in the past 24 months. As a responsible supplier, SMSC's goal is to minimize any negative impact this discontinuation may have on your production cycle. Therefore, the purpose of this letter is to describe SMSC's policy for the discontinuation, offer a last time buy opportunity, and to ensure proper notification of this program.

Attached below is a list of devices included in this Last Time Buy (pg.2) along with the timeframes for ordering and shipments. Also, included below are the standard SMSC terms and conditions for SMSC Last Time Buys. Please contact your SMSC regional sales office with any questions you may have.

Terms & Conditions for Last Time Buy

1. All P.O.'s must be placed by the date indicated in the LTB list attached.
2. All deliveries must be scheduled prior to the date indicated in the LTB list attached.
3. Order acceptance is subject to SMSC's Standard Terms & Conditions, including but not limited to, credit approval, minimum order requirements and minimum shipments quantities.
4. All P.O.'s are non-cancelable and cannot be rescheduled. This must be indicated on the Purchase Order.
5. Devices are not returnable except under SMSC's standard warranty. SMSC Distributors must request an RMA for any applicable products still covered under SMSC's standard warranty, by the Last Order Date as indicated on the Last Time Buy list. Devices purchased by an SMSC Distributor will not be eligible for stock rotation privileges.
6. SMSC reserves the right to limit orders to inventory existing at the time of P.O. placement. Customer acknowledges and agrees that the final shipment quantity and adjusted purchase order may vary +/- 5% depending upon final product yield. If existing inventory is not sufficient to cover customer purchase order, customer may be required to place purchase orders in increments of 25 wafers.
