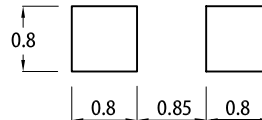

### RELATIVE INTENSITY vs. WAVELENGTH

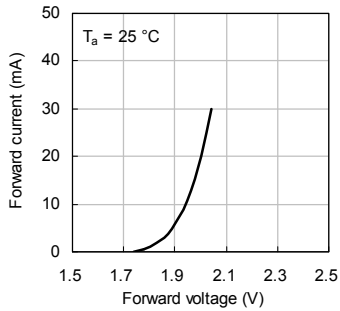


### SPATIAL DISTRIBUTION

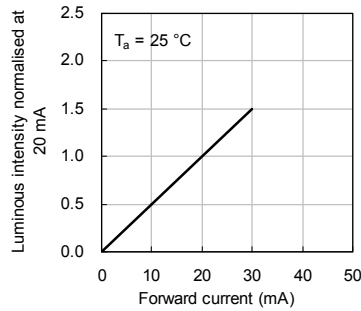

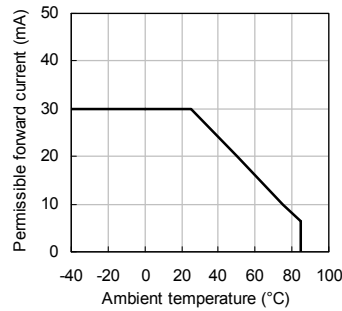
**Forward Current vs. Forward Voltage**



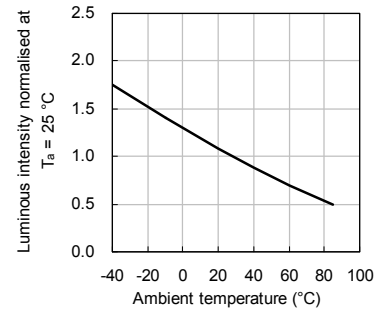
**Luminous Intensity vs. Forward Current**



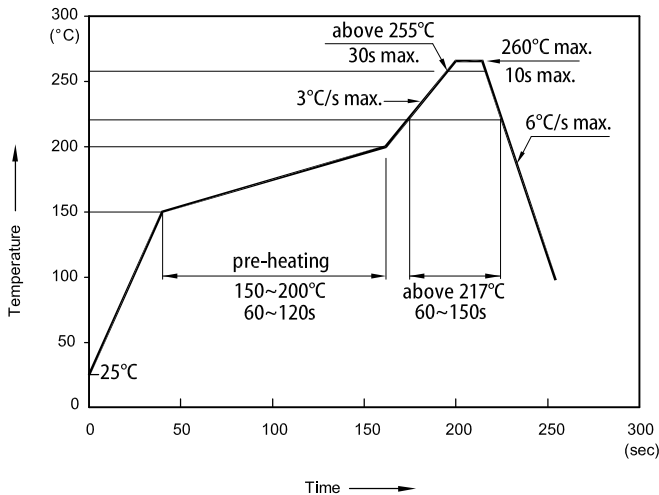
**Forward Current Derating Curve**



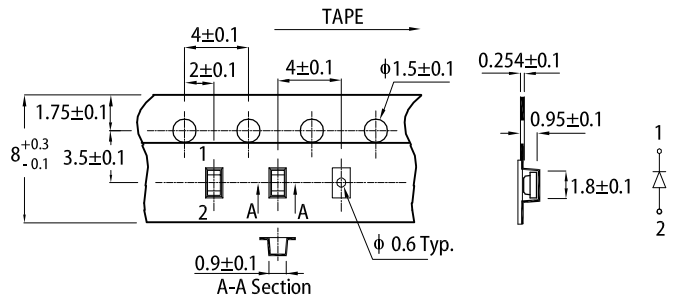
**Luminous Intensity vs. Ambient Temperature**



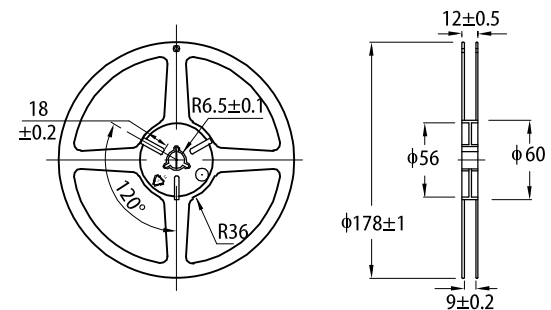
### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

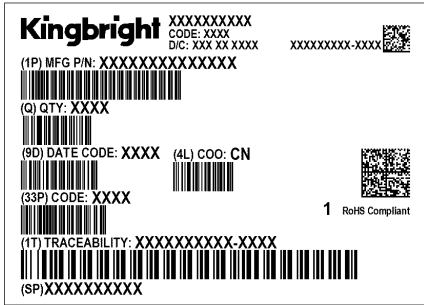
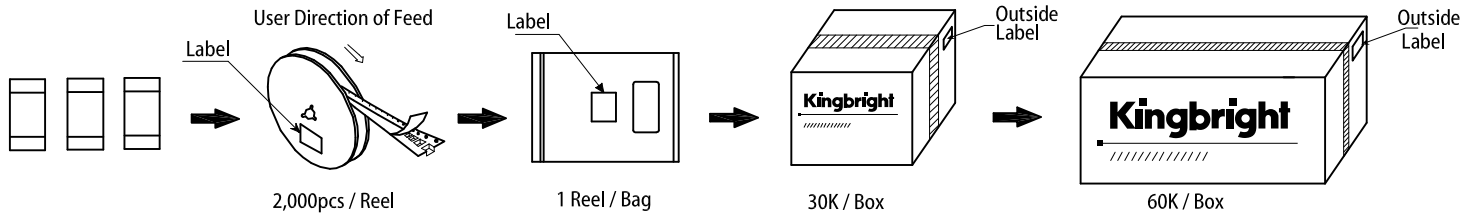


### REEL DIMENSION (units : mm)
