




Fig. 1 - Peak Pulse Power Rating Curve




Fig. 2 - Pulse Power or Current vs. Initial Junction Temperature




Fig. 3 - Pulse Waveform




Fig. 4 - Typical Junction Capacitance Uni-Directional




Fig. 5 - Typical Junction Capacitance





Fig. 6 - Maximum Non-Repetitive Forward Surge Current Uni-Directional Only




Fig. 7 - Typical Characteristics Clamping Voltage





Fig. 8 - Power Derating Curve
